# Request for an Adjudication Certificate Guidance Notes

## Section 1

1. The request must be lodged with the Authorised Nominating Authority which nominated the Adjudicator.
2. The request cannot be made before the expiration of either 5 business days after the Adjudicator's Decision was served on the Respondent or immediately after a later date (decided by the Adjudicator) as the date on which the progress payment became payable.
3. The request cannot be made unless the whole or part of the Adjudicated Amount remains unpaid at the date of the request.
4. The request must be accompanied by the fee charged by the Authorised Nominating Authority for issue of the Adjudication Certificate.

## Section 2

1. Interest **will not** be included in the Adjudication Certificate unless the Claimant completes Section 2.
2. Interest must be calculated at the rate decided by the Adjudicator in the Adjudication Decision. Interest is simple interest unless the Adjudicator has decided otherwise.
3. In calculating interest, the date upon which the progress payment became payable (as decided by the Adjudicator) should not be included but the date of this application should be included.
4. In respect of the amount decided by the Adjudicator, interest should be calculated only on unpaid amounts as at the date of the Request for an Adjudication Certificate.
5. The interest rate decided by the Adjudicator **does not** apply to adjudication fees.
6. Any interest calculation which covers two or more periods, must be shown as separate interest calculations.
7. The formula which may be used to calculate simple interest payable is as follows:

### Formula

### Example

### Rate Prescribed under the Court Procedures Rules 2006, schedule 2, part 2.2

The website of the Supreme Court of ACT confirms that the interest rate prescribed under the *Court Procedures Rules 2006, schedule 2, part 2.2* is calculated as follows:

- (a) for the period from 1 July to 31 December in a year—the rate that is 6% above the cash rate last published by the Reserve Bank of Australia before the start of the period; and
- (b) for the period from 1 January to 30 June in a year—the rate that is 6% above the cash rate last published by the Reserve Bank of Australia before the start of the period.

Therefore, the rate prescribed under the *Court Procedures Rules 2006, schedule 2, part 2.2* varies as the cash rate changes. The Claimant may consider reviewing the Reserve Bank of Australia website at [www.rba.gov.au/](http://www.rba.gov.au/) to satisfy itself of the relevant rate of interest. The following table provides what Adjudicate Today understands is the relevant interest rate under the *Court Procedures Rules 2006, schedule 2, part 2.2* for certain periods:

1/01/21 to 30/06/22	6.10
1/07/22 to 31/12/22	6.85
1/01/23 to 30/06/23	9.10
1/07/23 to 31/12/23	10.10

**\* In all cases, the Claimant MUST make its own enquiries to satisfy itself of the relevant rate of interest.**

### **Section 3**

1. If the Claimant has paid the Respondent's share (or part of the Respondent's share) of the fees of the Authorised Nominating Authority and/or the Adjudicator, the Claimant should complete Section 3.
2. Adjudication fees **will not** be included in the Adjudication Certificate unless the Claimant completes Section 3.

### **Declaration**

1. The Claimant must complete the declaration on Page 2 of the Application Form.
2. If the Claimant is a company then an officer duly authorised by the company should complete the Application Form.
